Information Technology (IT) Services

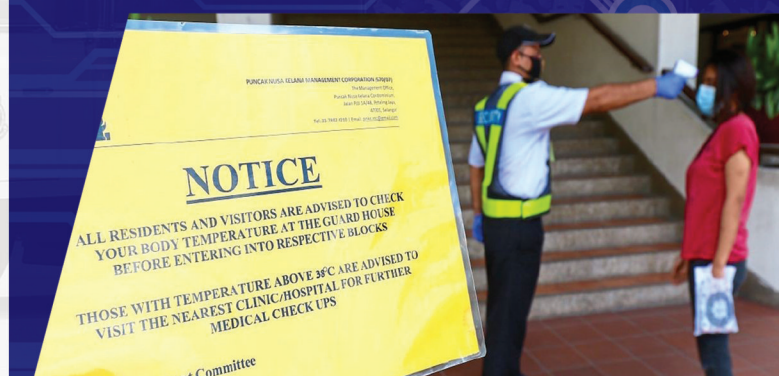
To cater with the growing needs on 'e-economy', the company has embarked on information technology services. Highly trained personnel in IT have been recruited to provide such services.

GUARD REQUIREMENTS

Generally, all guards employed by Vision Security Sdn Bhd are chosen from ex-police, ex-servicemen and civilians for a specific and well defined job scope. The main criteria emphasized:

- a. Matured individual but not exceeding 60 years
- b. Physically fit & mentally healthy
- c. Expert in certain fields
- d. Proven good track record
- e. Must pass identity and security vetting verification process set by Ministry of Home Affairs, Malaysia (KDN)

In addition, all security personnel are required to undergo the company's predefined training program with the assistance of other agencies such as the Polis DiRaja Malaysia (PDRM) and BOMBA (Fire & Rescue Department) before they could qualify to undertake their respective assignments.
